LINGNAN UNIVERSITY REGULATIONS GOVERNING RESEARCH POSTGRADUATE STUDIES

- 15.5. Two hard copies and one electronic copy of the approved thesis shall become the property of the University.
- 15.6. The copyright of the thesis is vested in the candidate.
- 15.7. Both hard and electronic copies of the thesis will be made freely available in the University and the Digital Library, and the library of the attached Department, unless an application for restriction (provided in Sections 15.8 and 15.9) is approved.
- 15.8. Where a candidate or the attached Department wishes the thesis to remain confidential or to be on restricted access for a period of time after completion of the work, application for approval must be made to the Postgraduate Studies Committee at the time of giving notice of intention to present the thesis. In cases where the need for confidentiality or restricted access emerges at a subsequent stage, special application for the thesis to remain confidential or to be on restricted access after submission must be made immediately. The period approved shall not normally exceed two years.
- 15.9. Where the Committee has granted approval to the application, the thesis shall be held on restricted access for a time not exceeding the approved period.
